### Who's on the Board of Trustees

The Firefighters Supplementary Pension Plan (FSPP) board of trustees consists of 7 members. The Plan Sponsors (The City of Calgary and the International Association of Firefighters – Local 255) appoint three representatives each and together all six trustees select an independent trustee. The Board meets formally at least quarterly and more often when necessary in addition to conducting plan activities between meetings. The Board members are:

## **Dave Schnore (Chair)**

Dave Schnore joined the Board of Trustees of the Calgary Firefighters Supplemental Pension Plan as Chair in January 2024. Dave was employed by the Universities Academic Pension Plan (UAPP) for over 15 years and retired as Executive Director in early 2024.

Prior to joining UAPP, Dave was a pension consultant with Aon Consulting from 1989 to 2008. Dave commenced his career in 1981, working with various types of retirement plans as an Account Manager with the National Trust Company.

Dave is a member of the International Foundation of Employee Benefit Plans where he has been a moderator at conferences, has spoken at industry seminars such as the Canadian Pension & Benefits Institute, and has been an instructor for the Humber College Pension Plan Administration Certificate program.

### **Andrew Cutforth**

Andrew Cutforth was appointed by the International Association of Firefighters (IAFF) - Local 255 to serve on the Firefighters Supplementary Pension Plan Board in 2018. Andrew has been a Firefighter with the Calgary Fire Department since 2003. He is currently serving as a Captain on "B" shift. Prior to joining the Calgary Fire Department, Andrew served as a Grande Prairie Firefighter from 2001 to 2003.

# Jamie Blayney

Jamie Blayney was appointed by the International Association of Firefighters (IAFF) - Local 255 to serve on the Firefighters Supplementary Pension Plan Board in 2020. Jamie has been a Firefighter with the Calgary Fire Department since 2005. He is currently serving as a Lieutenant/Acting Captain on "A" shift. Prior to joining the Calgary Fire Department, Jamie was employed for 13 years in the private sector working for Loblaws Canada holding several Finance positions. Jamie also served on the Local 255 Executive Board from 2014 – 2020 and 2023 – Present as Association President.

Josh Sutherland was appointed by the International Association of Firefighters (IAFF) - Local 255 to serve on the Firefighters Supplementary Pension Plan Board in 2025. Before coming to Calgary, Sharon held an over 15-year tenure at the City of Toronto in a variety of business areas including corporate services, public works administration, waste and recycling, and fleet.
